INTRODUCTION

The Annual Report is a culmination of the Quarterly report and is designed to provide the Southern Chester County Regional Public Safety Commissioners, Managers, Command Staff, and other readers a wide-ranging perspective of the activities and experiences of the organization, during the established timeframe.

The report is a collective effort, primarily produced by the Chief of Police and Command Staff. The report is broken down into the four functional categories of the organization. Towards the end of every functional area, the writer is required to provide a projection of upcoming events, activities or other noteworthy matters. Finally, the report will attempt to follow a standard format, but accepts that the contents may evolve as the organization does.

Executive Division

The Executive Division is overseen by the Chief of Police. The Executive Division is responsible for the operational components, personnel, administrative, budgetary, and personnel matters in the organization.

The Executive Division is staffed with an Executive Assistant, Records Administrator, Manager, that serves as a liaison to the Public Safety Commissioners, and the Command Staff Officers, that oversee each operational division.

Special Operations Division

The Special Operations Division is overseen by the Deputy Chief. The Special Operations Division is responsible for Criminal Investigations, Special Investigations, Community Services, Training, Staff Services, and Professional Standards. The Special Operations Division is assisted by the Chief's Executive Assistant who serves as a member of the Command Staff.

Patrol Division

The Patrol Division is overseen by the Sergeant. The Patrol Division is responsible for all Field Operations and is the direct supervisor of the Platoon Corporals. The Patrol Division is assisted by the Chief's Records Administrator who serves as a member of the Command Staff.

RELEASE OF 2018 ANNUAL REPORT – COMMENTARY

In the two-years since our inauguration, I have been asked countless times --- how's that regional thing working out? Admittedly, my responses at times may have appeared to lack the enthusiasm and zeal I energetically displayed that winter evening on January 12, 2017.

Unforeseen and unanticipated challenges can make even the most confident and passionate leader question their decisions. Fortunately, patience and persistence have yielded fruits of our team's many labors. My response to that question --- *This "regional thing" is by far the best arrangement (for us) to deliver high quality public safety services at an economically stable cost!*

The Southern Chester County Regional Police Department publishes three quarterly and one annual report. We hold ourselves accountable and in the spirit of transparency, we release these reports and invite the public to question our work. We hope our readers take time to evaluate the data and commentary. We perform analysis in perpetuity, so that we can hopefully be ahead of trends that can often have detrimental impacts on a communities' quality of life.

Crime Data

The communities served by the Southern Chester County Regional Police Department experienced a ten percent (10%) reduction in Part I crime and a two percent (2.15%) reduction in Part II crime. Our total crime activity experienced a nearly four percent (4%) decrease in year 2018 when compared to the year 2017.

The Part I crime category that experienced the largest decline is the crime of Burglary, which had an overall reduction of thirty-six percent (36%). This is a result from having dedicated investigators that are trained and equipped to handle complex cases. Additionally, we believe that having a proactive and visible policing model creates an atmosphere of omnipresence and thus deterring the opportunities to commit crimes.

Traffic Data

The communities served by the Southern Chester County Regional Police Department have also experienced a seven percent (7%) increase in traffic collisions in the year 2018 when compared to the year 2017. Empirical evidence points to inclement weather as being the primary factor for the increase in collisions.

Traffic citations and the subsequent punitive enforcement actions have increased by thirty-nine percent (39%). In 2018, the department participated in several aggressive driving initiatives throughout the year, but also during historically high-volume periods, such as holiday travel. This may account for some of this increase.

DUI arrests are up by a staggering sixty-six percent (66%) in the year 2018 when compared to the year 2017. The preliminary data suggests that this a result of officers being better trained to detect driving under the influence of alcohol, but also under the influence of drugs. Twenty-nine percent (29%) of all DUI incidents were a drug related incident.

Budget Data

In addition to our communities having a safer community, the good news culminates with the announcement of a nearly ten percent (10%) decrease in projected costs to operate the Southern Chester County Regional Police Department.

Price-point --- or, how much does each police officer cost?

The 2018 approved budget was \$2,597,115.00 which established a price-point that was an approximately \$129,856.00 for the cost of each officer.

As stated above, partnering has revealed savings to both our communities. Although the audit is pending, we are confident that the partnership has revealed an estimated 10% decrease in our projected 2018 budget. This brings our officer price-point to an estimated \$116,872.00 for each officer.

It is worth reminding our readers that when the regional feasibility study was first completed by the Department of Community and Economic Development (DCED) our project budget for the year 2015 was estimated at \$3,040,000.00. The set our price-point at an estimated \$152,000.00 for each officer. In 2018, we operated the department at twenty-three percent (23%) less than an estimated 2015 budget. Don't costs usually increase with time?

Our efforts to stabilize public safety costs have succeeded; partnering has created a reduction in overall costs. Economizing to scale, having a fair Collective Bargaining Agreement along with an aggressive stewardship and management style of the budget have contributed to these positive results.

We build upon every achievement with a vision towards the next year. The projects planned for 2019 and beyond would not be possible without creating positive opportunities every day. I am going to outline a few of our projects for 2019. Updates on our progress will be included in our quarterly reports.



First, with the accolades of success, we must also own the blunders. Admittedly, I didn't get everything right in the first personnel design of the organization. So, at 7:30 pm on Thursday, January 17th, 2019 at the Public Safety Commissioners Meeting (299 Starr Road, Landenberg, PA 19350) we get an opportunity to correct this error.

It brings me pleasure and immense pride to announce the promotion of Joseph F. Greenwalt to the rank of Lieutenant. Since 2017, Lt. Greenwalt has been serving on the Chief's Command Staff along with performing duties on the Management Team. We are pleased to make his official title and benefits equal to his outstanding performance to the Regional Police Department and our

communities. Lt. Greenwalt will remain in command of the Patrol Division, along with his new appointment as our Accreditation Manager.

A perfect segue into our primary objective for 2019 --- The Southern Chester County Regional Police Department is proud to announce we registered to become a PLEAC Accredited Law Enforcement Agency. Currently, there are 116 accredited police agencies across the Commonwealth. Lead by Lt. Greenwalt, I am confident that we have designed a team of employees and facilitators to ensure our success. The Accreditation team has established an aggressive timeline to accomplish this prestigious endeavor. Stayed tuned for updates through the year!



On a personal note, I have been accepted to the Command and Leadership Academy, a 14-week laborious training regimen which began on January 9, 2019. The training is based on a West Point Military Academy curriculum.

While I have been in a leadership role for the past 20 years, I believe you can never stop learning or polishing your skills. Excited and nervous to say the least, but I look forward to being in a spirited learning environment where leadership, behavioral motivation, stress management and effective communication are the topics of higher learning.

2019 Forecast

In 2019 we hired an additional police officer, which allowed us to create a Traffic Safety Unit. This sole officer will be tasked with several objectives, to include collision and speed analysis, effective enforcement details and fleet management. Later in the year, the TSU officer will attend training related to commercial vehicle enforcement. Below is a photograph of the TSU police vehicle.



After hosting the groundbreaking ceremony on September 12, 2018, the new police facility construction paused briefly. However, construction began in earnest in October of 2018. With the foundation poured and the walls of the institutional side up, the office walls and roof should soon follow.

By far, this is the most exciting public project underway in 2019! We anticipate opening our doors in the Summer of 2019. Keep posted for updates.



In an effort to better understand and gain the necessary information to address our communities' needs, the police department intends to offer web-based survey opportunities throughout the year. The surveys will be advertised on our social media sites; Facebook, Twitter, etc. with a link to our webpages.

As I concluded my commentary, I hope it gives you a context of our experiences from 2018 and a glimpse into what's to come in 2019. We will continue to analyze the data in the hopes to better understand the trends.

It is worth noting the Command Staff attributes this good news to a Labor and Management team committed to working together and achieving results. Their efforts resulted in a new labor contract for sworn personnel for the next four years.

The Southern Chester County Regional Police Department is staffed by dedicated professionals who are committed to providing our residents, businesses and visitors a safe and prosperous community! We could not be more pleased with the results of our second year in existence, which in the final analysis supports our motto:

"United to Serve Our Communities with Excellence"

In conclusion, none of this could have been accomplished without the support of the Public Safety Commissioners; their guidance has given us an opportunity to succeed. To the communities of New Garden Township and West Grove Borough, we appreciate your trust, confidence, and support. We look forward to building upon this success in 2019.





BIASED BASED POLICING

Consistent with the recommendations of the 2015 President’s Task Force on 21st Century Policing, Pillar #1 --- Building Trust and Legitimacy, below is traffic stop demographic data through the 4th Quarter of 2018.

The below charts captured from Towncharts.com state that, according to the most recent demographics data available from the Census Bureau released in December of 2017, the breakdown for New Garden Township and West Grove Borough are as follows:



During the 4th Quarter of 2018, the Southern Chester Regional Police Department stopped a total of **803** motorists. Of the total traffic stops, an average of 82% concluded with an enforcement action. The following is an analysis of the demographics.

2018 BUDGET COMMENTARY

The following is a summary to highlight the manageable areas of the 2018 budget; these numbers are as of December 31, 2018.

Part-time Salary – 01-410-144:

\$220,000.00 was budgeted for 2018 part-time salary expenses. At year's end, approximately \$216,462.00 was used to pay for 8400 hours. Ninety-eight percent (98.40%) of the budget was used.

Overtime Expenses – 01-410-183:

\$50,000.00 was budgeted for 2018 overtime expenses. At year's end, \$49,577 for 1,149 hours were disbursed from various categories. Sixty-two percent (62%) of the overtime spent was used for reimbursable extra-duty assignments.

The next highest overtime category, representing ten percent (10.52%) was for shift coverage when the department experienced two unanticipated employee departures.

It should be noted that \$59,810.00 in revenue was received from Extra Duty assignments.

Fleet Maintenance – 01-410-250:

\$20,000.00 was budgeted for vehicle repair expenses. At year's end, \$22,477.00 for a deficit of twelve percent (-12.39%). A total of one hundred and thirty-seven (137) purchase orders were authorized for repairs and maintenance. We reported our anticipated shortfall in the 3rd Quarter Report, estimating that this category would exceed 2018 budgetary limits by approximately 10%.

Contracted Services – 01-410-450:

\$42,000.00 was budgeted for contracted services expenses. At year's end, \$42,850.00 for a deficit of two percent (2.03%). A total of one-hundred and four (104) purchase orders were authorized. We reported our anticipated shortfall in the 3rd Quarter Report, estimating that this category would exceed 2018 budgetary limits by approximately 8%.

COPS Hiring Award:


The department received a COPS Hiring award for \$125,000.00 over a span of three-years. \$43,547.00 was budgeted to drawdown to offset the expenses of hiring a new police officer. Through the 4th quarter four payment requests have been submitted for a total of \$43,547.00.

Revenues:

The total revenue received through the end of 2018 is a total of \$195,280.07; see the chart below for category breakdown:

SPECIAL OPERATIONS DIVISION

Administrative Shift Coverages

The Special Operations Division (which includes, the Criminal Investigations Unit, the Tactical Intelligence and Support Unit, and the Community Services Unit) cooperates with the Patrol Operations Division by assisting with uniformed patrol coverages. This not only maintains a balanced budget, but also ensures adequate staffing during peak leave request periods. This scheduling adjustment maintains a healthy stewardship over the overtime and part-time police officers budget areas. During the 4th quarter, the SOD mitigated overtime costs by working 204 of shift coverage.

Quality of Life

Speed Studies

SOD personnel support Patrol Division efforts by deploying the Department's JAMAR speed recording device at various locations throughout both communities. This is done both to corroborate citizen complaints about speeding and to proactively identify trouble spots where target enforcement details can then be scheduled. During this quarter, there were no citizen complaints of speeding and no speed studies conducted; However, there is one pending for early 2019.

Special Operations Division Proactive Enforcement

When not assisting with shift coverage obligations or Community Service events, the SOD/CSU supplements patrol sector efforts with proactive traffic and parking enforcement. In the 4th quarter of 2018, SOD personnel contributed as follows:

Professional Standards

One Internal Affairs Investigation was initiated in the 4th Quarter of 2018. It is still an active investigation and will be concluded and reported upon in the first quarter of 2019.

There was at-fault Department Vehicle Accident during the 4th quarter. A minor collision with no damage occurred when a Department owned unmarked vehicle backed into another vehicle, as it pulled into a parking spot behind the police vehicle, in the city of Wilmington, DE. The incident resulted in a verbal reprimand

4th Quarter Use of Force

A Use of Force Committee is put together each quarter to review all incidents submitted during that time period. The Deputy Chief serves as the committee chair person. On January 9th, 2019, a Use of Force review board was convened and the following incidents were reviewed:

The below Use of Force reports were submitted to document the destruction of an animal during the 4th quarter. After thorough review, these reports were found to be in compliance with policy. **Animal Destruction:** (In all of the below cases, police discharged their service weapon to put down deer that were struck by vehicles):

The below incidents are circumstances where a force option was used and the officer's actions were found to be in compliance after review:

1. **RD-18-003101:** While investigating the report of a possible burglary in-progress at an apartment building, police unholstered their duty weapon and gave verbal commands to a subject, who was later determined to be the tenant. A contractor reported that the apartment door had been kicked in but it was later determined that the damage had occurred the previous night, when EMS had to force their way inside to render medical aid to the tenant.
2. **RD-18-003238:** Upon responding to a report of an armed subject threatening a neighbor with what was believed to be a rifle, police displayed department issued firearms and gave the subject verbal commands. He was taken into custody without incident. The object thought to be a rifle was later determined to be a long piece of rebar that the subject was holding and pointing at the RP and police as though it was actually a rifle.
3. **RD-18-003411:** Police had to physically restrain an out of control juvenile who was throwing musical instruments at school staff and police. The juvenile was subdued and calmed down without sustaining injury.

4. **RD-18-003634:** After responding to the report of a physical domestic assault, police displayed their issued service weapon, after the suspect crawled under a bed and they could not see his hands. Once it was determined that he did not have a weapon, he was pulled from under the bed and after a brief struggle, he was taken into custody. No injuries were sustained.
5. **RD-18-004036:** Following a traffic stop and after detecting the odor of marijuana, officers requested that the operator exit the vehicle so a probable cause search could be performed. The operator refused and attempted to hold the door shut with his arm. Physical force was used to pull the driver from the car and place him in custody. No injuries were sustained.
6. **RD-18-004051:** Officers were dispatched to a report of a disturbance during which an intoxicated subject entered another's home. Upon arrival, Police located the subject. He ignored commands to show his hands and walked towards the officers. One officer drew his issued service weapon and the other officer drew his issued Taser. With cover from the Taser, one officer holstered his weapon and used a compliance hold to take the subject into custody. In doing so, the subject sustained a small laceration above his eyebrow. He refused treatment by EMS.

Significant Activity

Analysis of crime reporting data in 4th quarter of 2018 identified the following cases or crime trends as being noteworthy:

Burglary

The CIU is currently investigating a residential burglary in which nearly a half million dollars in jewelry, as well as a gun, and other assorted items were stolen. The incident was discovered on October 19th, in New Garden Township. The stolen gun was recovered after it was subsequently used in a shooting in Wilmington. That suspect is in custody in DE. With assistance from the Wilmington Police Department and the Delaware State Police, additional arrests have been made, search warrants have been executed, and a considerable amount of the stolen jewelry has been recovered. The case is still active.

Rape

The CIU followed up on an investigation initiated in early June and which occurred in New Garden Township. Evidence was sent to the lab for analysis and a search warrant for the suspect's DNA was executed. A suspect was arrested and charged in October. The case is pending trial.

Reports of Suspected Child Abuse

The CIU is currently investigating a residential burglary in which thousands of dollars in jewelry was reportedly stolen.

Reports of Suspected Child Abuse

In the 4th Quarter of 2018, the CIU has received twelve (12) reports of suspected Child Abuse (physical and sexual). Pennsylvania's Child Protective Services Law was amended in 2014 to include substantial changes and additions to the list of those persons/professions who are "Mandatory Reporters". Once a report is made, it is disseminated to the appropriate agencies and each is investigated in a timely manner. Of these (12) cases, some have been closed as unfounded but several are still either active or are pending prosecutorial direction from the District Attorney's Office. These often require very labor-intensive investigations just to determine if they are criminal in nature or are matters best handled by social services.

Rape

The CIU investigated an alleged rape that was reported to police on October 21st. The crime reportedly occurred in the parking lot of a business in New Garden Township, inside a company tractor trailer that the suspect drives. Search warrants were executed and a suspect has been charged. The case is pending trial.

Attempted Homicide/Aggravated Assault

The CIU is currently investigating a shooting that occurred on December 17th, on the property of a mushroom company in New Garden Township. During an altercation, involving numerous subjects (including several from Brooklyn, NY that are believed to be involved in prostitution), one male attacked another male with a machete and was then shot in the stomach by an unknown subject. The shooting victim was driven from the scene to Christiana Hospital, prior to police arriving. He was admitted and has since be released. The investigation is still active but police are receiving little cooperation from anyone involved. Charges are expected in the coming months.

Criminal Investigation Unit Staffing

Cpl. Jason Ward is assigned to the CIU as the primary investigator. He receives investigative assistance and technical support from Det. Stephen Madonna, who performs CIU and Intelligence functions. Both investigators are assigned to the Chester County Municipal Drug Task Force (MDTF) and Det. Madonna is also assigned to the Department of Homeland Security (DHS) Task Force. Additionally, P.O. Richard Townsend provides occasional CIU coverage when both investigators are unavailable, due to training or court, and he provides assistance with forensic expertise and evidence processing.

- DC King gave blocks of training on the topic of “Major Case Protocol” at three in-service training sessions in November.

Technology Making a Difference

SCCRPD Unmanned Aircraft System (U.A.S.) Update

During the 4th Quarter of 2018, the Department’s Unmanned Aircraft System was used to take aerial photographs of a possible crime scene. It has also been used to memorialize the progression of the new police station construction, in order to provide a future slide show once it is complete.





Core Values in Action

Supervisor Notations are internal reports filed by ranking officers who have either identified a positive interaction between a police officer and the public or have been informed of a job well done. Supervisor notations are a certain way to letting the department's police officers know that leadership is paying attention to actions which are considered going above and beyond to honor our values and philosophy. The notations are added in the officers personnel file for permanent record. Below are a few of these notations worth sharing.

#18-07 On 12/14/2018, PO Raymond Sullivan was on patrol in the 9000 block of Gap Newport Road, where he observed a vehicle stopped in the northbound lane. A short time later, he observed the same vehicle stopped in the southbound lane of Sharp Road, approximately 100 yards south of Gap Newport Pike. As he approached with his patrol vehicle, the driver left at a high rate of speed, disregarding the stop sign for Sharp Road and Gap Newport Pike and began travelling southbound on Gap Newport Pike. The vehicle began swerving and crossed over the double yellow lines before coming to a stop in the southbound lane of travel.

PO Sullivan activated his emergency lights and began investigating the suspicious behavior and erratic driving. PO Sullivan observed the driver to have wet paint on his hand and paint on his clothing. The driver was also displaying signs of impairment. The driver informed PO Sullivan that he stopped in the middle of the roadway to photograph the abandoned building at 9109 Gap Newport Pike.

After confirming the driver was impaired and taking him into custody for suspicion of DUI, PO Sullivan and assisting officer, PO Krissinger, continued to investigate the incident. Officers observed freshly painted "tags," which were the same color the driver had on his hand and clothing, on the building the driver was allegedly about to photograph. A search of the vehicle produced a THC vape pen and a large quantity of spray paint throughout the vehicle. A scrapbook with the same "tags" that were observed on the building was located in the suspect's vehicle as well.

PO Sullivan and PO Krissinger looked past the traffic stop and the obvious violations and made observations that led them to believe there was more criminal activity that had occurred. Acting on their instincts, they investigated further and were able to not only apprehend an impaired driver, but a vandal.

I would like to recognize the investigative efforts put forth by PO Sullivan and PO Krissinger and their willingness to take the steps necessary to dig deeper and, in this case, take an impaired driver off the street and possibly rid the area of a source of vandalism.

#18-08 On December 17th, 2018 at 0834 hours, this department responded to 6623 Limestone Rd. for the report of a fight out involving up to ten subjects. While Officers David Madonna and Raymond Sullivan were in route to the location, updated information revealed that the caller also heard what he believed to be gunshots. Upon the quick arrival of Officers Madonna and Sullivan at 0837, all of the actors had left the area and contact was made with the only person out there. These officers were advised there had been a fight involving numerous people and that large knives and a handgun were observed. In addition to this information, officers were advised that a gunshot was heard and one of the males leaving the scene left holding his stomach area as if he was injured.

The purpose of this notation is to commend officers Madonna and Sullivan and how they took the little bit of information they were provided and immediately preserved this now empty lot into a very active crime scene and this is how they did it.

Once information of a handgun, an injured person, knives and possibly shots fired were learned these officers began to think on a different level. Some may have simply said there is nothing to see here because everyone is gone, but officers Madonna and Sullivan did just the opposite. They began to take investigatory steps by combing the scene and in doing so located a shell casing partially sticking up out of the mud near the front door of the residence attached to the mushroom house. They continued to investigate and observed small traces of smeared blood and a muddy boot print on the front door to the same residence. Based off of this newly discovered evidence, these officers quickly realized there was more to this fight out. Officers made contact with the occupants of said residence and knew something about their initial statements was not adding up. The officers made notifications to their supervisor and alerted surrounding hospitals that an injured person may be on the way.

These two officers then locked down the area, secured a crime scene, separated witnesses and potential suspects and waited for assisting personnel to arrive. Shortly after a crime scene was established, Christiana hospital alerted Chester county radio that a shooting victim had just arrived and it did in fact occur at the now secure scene. Officer Sullivan responded to the hospital and was able to secure the vehicle involved that transported the shooting victim as well as two females that drove to the hospital with the victim

It is worth commending these officers for the following reasons:

- Detailed interviewing of initial caller by asking additional questions.
- Investigatory steps that lead to the discovery and containment of physical evidence (shell casing, blood smudges, boot print)
- Securing of crime scene and proper use of crime scene log
- Securing and separating of numerous witness and potential suspects
- Locking down involved residence for the purpose of obtaining a search warrant
- Securing the vehicle involved and witnesses that drove to the hospital with the victims

It was due to these officer's initial response that responding investigators possessed the necessary information, persons and evidence to conduct proper follow up. Nice work!!

Aggressive Driving Grant

The Southern Chester County Regional Police Department was awarded a grant from the Chester County Highway Safety Project to enforce Aggressive Driving behaviors and Seat Belt violations. The grant period is designed to influence driving habits, reduce collisions and ensure that motorists and their passengers are wearing their seat belts.

It is our hope that with our efforts to enforce speeding, tailgating, disregard of traffic signals and related offenses, we can influence driving behaviors to reduce serious collisions and keep the motoring and pedestrian traffic safe.

Below are the results from several selective enforcement details conducted in 2018. The locations were selected where accidents and violations were prone based off of data collected from our reporting system.

SCHOOL RESOURCE OFFICER



On November 5th, PFC Mario Raimato was re-assigned to the Special Operations Division / Community Services Unit and immediately assumed the role of our full-time School Resource Officer (SRO). He is responsible for patrolling the three Kennett Consolidated Schools that are in New Garden Township: Bancroft Elementary, New Garden Elementary, and the Kennett Middle School. This grant-based position demands close attention and tangible results to ensure its ongoing existence and success. While this program is in its infancy, as far as this Department and the schools in our jurisdiction are concerned, PFC Raimato has embraced his new role and continues to look for ways to improve his relationships with the students and the staff, and to provide for their safety. In 2019, PFC Raimato will spearhead education and training

consistent with the "Stop the Bleeding" protocols and will work with the KCSD to secure the needed supplies to create trauma kits for use in the schools. Below is correspondence that Superintendent Barry Tomasetti sent to parents:

Dear Parents,

As you know, keeping our children safe is our highest priority at the Kennett Consolidated School District. We are continually reassessing our needs and securing the resources to meet them. I am pleased to announce that with the first-ever of its kind, the Southern Chester County Regional Police Department has secured a \$60,000 school safety grant, which together with an investment from the District will afford an

additional full-time school resource officer.

For the last five years and with great success, we have employed a school resource officer at Kennett High School and Mary D. Lang Kindergarten Center. This new partnership with the Southern Chester County Regional Police Department will allow the District to employ a second full-time school resource officer at our New Garden Township schools, namely, Bancroft Elementary, New Garden Elementary, and Kennett Middle School.

PFC Mario Raimato, a career police officer and Kennett Square native, is already a familiar face to our students having served with our lunch program last year eating lunch with our students on a weekly basis. Beginning November 5, Officer Raimato will be in our schools full-time using his knack for interacting with children to build relationships and to ensure safety and security within our buildings. Our ultimate goal is successful educational outcomes, and we anticipate Officer Raimato's presence will contribute to that mission by allowing our children to feel more confident and secure at school.

We are indebted to the Kennett Square Police Department and the Southern Chester County Regional Police Department for their dedication to the safety of our community and schools, and we remain grateful to you for entrusting us with your children.


Spread the "Warmth" Winter Clothing Drive
